Business Torts and Non-Compete Litigation

- Defended a **manufacturer** in four-week federal jury trial, the first jury trial under the Defend Trade Secrets Act. Won a jury verdict that completely rejected non-compete claims.
- Defended large international generic **pharmaceutical** company against claims under the Defend Trade Secrets Act and the Computer Fraud and Abuse Act. Secured a cost-of-defense settlement.
- Currently prosecuting trademark infringement, dilution, and unfair trade practices claims on behalf of large **greeting card company**. Secured a preliminary injunction within one week of filing that stopped further infringement.
- Served as lead counsel to a large **insurance** company, successfully enforcing a non-solicitation agreement and favorably prosecuting a tortious interference claim against a former broker and his new employer, resulting in a favorable settlement securing a stipulated injunction enforcing the agreement's terms and obtaining a monetary payment.
- Served as lead counsel in the successful defense against the enforcement of a non-solicitation agreement, tortious interference claim and fraud claims against a large **insurance** company and broker, resulting in a favorable settlement.
- Pursued a preliminary injunction on behalf of a *Fortune 500* **manufacturer** against former employees to enforce non-compete and nonsolicitation agreements, obtaining favorable settlement.

Arbitration and Complex Commercial Litigation

- Obtained an eight-figure award on behalf of a client after a one-week international arbitration hearing before the London Court of International Arbitration relating to a failed international **real estate joint venture**, developing a winning argument based on market evidence in India.
- Led the representation of a **foreign software provider** in an international arbitration concerning a software implementation, turning a \$1 million claim against the client into a settlement payment for the client.
- In *Bevan v. DaVita, Inc.*, (10th Cir.), won affirmance of confirmation of an underlying arbitration award after successfully defending against breach of non-compete, breach of fiduciary duty and fraud claims.
- Defended and prosecuted two arbitrations on behalf of a **medical device manufacturer**, turning an initial multimillion-dollar claim against the client into a multimillion-dollar settlement for the client.
- Prepared for an arbitration hearing within 60 days from first filing in a \$100 million dispute concerning an underlying patent litigation settlement on behalf of a **cable provider**, leading to a favorable settlement.
- Prosecuted a breach of exclusive supplier contract claim in an AAA arbitration on behalf of a **major bottling company**, leading to a favorable monetary settlement.
- Currently defending a **casino** against antitrust claims, successfully employed strategy limiting defense costs.
- Defended **university** against fiduciary duty claims brought by current and former students.
- In *Princeton Football Partners LLC v. Football Association of Ireland* (D.N.J.), on behalf of the **premier Irish soccer association**, obtained dismissal of a complaint alleging RICO, breach of contract and tort claims.

Securities, Financial Services and M&A-Related Litigation

- In *Hamilton Partners, L.P. v. Highland Capital Mgmt., L.P.*, (Del. Ch.), won dismissal of a complaint alleging breach of fiduciary duty claims against a director in a stockholder class action.
- In *Alliance Industries, Inc. v. Longyear Holdings, Inc.*, (W.D.N.Y.), won summary judgment on behalf of large **mining exploration company**, defeating breach of contract and tort claims while obtaining an award for breach of representations and warranties in an asset acquisition agreement and an award for attorneys' fees.
- Currently defending a **mortgage company** against a collective action and a separate class action alleging failure to pay overtime.

- Led the defense of a **mortgage company** relating to mortgage servicing claims in federal court, leading to favorable settlement.
 - Defended a **mortgage company** in a trading desk dispute, leading to an early cost-saving settlement.
