### Representative Matters\*

- *Steiner v. Steiner*, 470 N.J. Super. 112 (App. Div. 2021), cert. denied, 250 N.J. 387 (2022), and cert. denied, 250 N.J. 358 (2022): Appellate Division reported a case of first impression involving the adjudication of grounds for divorce under irreconcilable differences. Ordered no punitive counsel fee awards for meritorious defenses of claims.
- *Barr v. Barr*, 418 N.J. Super. 18 (App. Div. 2011): Appellate Division reported decision covering equitable distribution of a military pension, part of which accumulated through post-divorce efforts.

- Collection of approximately \$400,000 in child support and alimony arrears, accumulated over 20 years, on behalf of a client whose former husband “forum-shopped” between New Jersey and California to secure more favorable support orders. The ruling was affirmed in the Appellate Division.
- Assisted in the successful adjudication of the validity of a New York prenuptial agreement.
- Secured a judgment that blocked the return of two children to Dubai, UAE. The mother fled the country to escape domestic abuse and the country’s patriarchal society. The case involved the retention of an expert versed in Middle Eastern law and societal mores who opined that the mother would be denied due process in any custody dispute in Dubai.
