- Obtained complete dismissal of \$600 million False Claims Act claim.
- Obtained complete dismissal of \$4.5 million consequential damages claim in commercial dispute.
- Won summary judgment and had that decision upheld by the Pennsylvania Superior Court in a case of first impression holding that the Uniform Condominium Act does not authorize a condominium association to unilaterally terminate a property owner's easement rights in condominium association property.
- Obtained a unanimous jury verdict of no cause of action on behalf of a global credit card company in federal court in Cincinnati.
- Vindicated a bank against lender liability and bad faith claims.

 - Defense of a pharmaceutical company against claims related to diet drugs.
